Job Title: Special Projects Coordinator

SUMMARY

This is a professional position, wherein the incumbent is responsible for coordinating naloxone trainings, outreach, and tracking naloxone distribution throughout the county. Incumbent must have dependable transportation and be able to work flexible hours, according to need. This position contingent on grant funding.

ESSENTIAL DUTIES AND RESPONSIBILITIES include, but are not limited to, the following. Other duties may be assigned.

- Provide and coordinate trainings to law enforcement, medical professionals, pharmacists, treatment providers, key stakeholders, and lay persons on topics such as best practices for prescribing opioids, pain management, recognizing potential cases of substance use disorder, and referrals to treatment programs. Trainings will be in the form of medical forums and town hall meetings.
- Incumbent will utilize evidence-based resources including, but not limited to the CDC Opioid Prescribing Guidelines, SAMSHA's Overdose Prevention Toolkit, Harm Reduction Guide to Developing and Managing Overdose Prevention and Take-Home Naloxone Projects, Stanford's Chronic Pain Self-Management Program, and the Good Samaritan Law.
- Conduct individual and group training sessions to educate and distribute Naloxone kits to individuals in the community who are affected by opiate use and overdose.
- Conduct outreach in the communities of Sequoyah County to promote the Sallisaw NOW Opioid Overdose Prevention Project and its services.
- Provide training to individuals regarding naloxone use through outreach efforts to other non-profits and community organizations.
- Participate in strategic planning for outreach and promotion of the overdose prevention program.
- Conduct trainings in a variety of environments, including traditional and non-traditional settings (i.e. housing programs, faith-based settings).
- Network with organizations who are need of Naloxone training.
- Complete all required documentation to track all trainings delivered and kits distributed.

- Appear for scheduled work with regular, reliable, and punctual attendance
- Performs other duties as assigned

OUALIFICATIONS

Bachelor degree with at least one-year experience in either behavioral health or public health. Strong computer skills.

Must have strong oral and written communication skills, strong interpersonal and leadership skills, be well organized and able to multitask. Contact with others beyond immediate associates, but generally of a routine nature, Frequent contact with general public, patrons or other outside representatives.

REASONING ABILITY
